## **Recent Taxwise Engagements Summary**

#### 1. Summary of recent Cases at the Tax Appeals Tribunal and High Court

- Successfully represented the Shipping Companies as an industry at the Tax Appeal Tribunal as to the imposition of Withholding Taxes on demurrage charges and detention fees and who bore the responsibility to account and as to the payment of VAT on the bill of lading and delivery order fees;
- ✓ Successfully represented one of the major banks in Kenya at the Tax Appeals Tribunal and High Court against a demand of Kshs. 89,000,000 relating to excise duty on interchange fees and money transfer services.
- ✓ Successfully represented and got favourable orders on behalf of a Client in a Kshs. 2.3 billion demands by the customs department on alleged import duties.

However, based on the nature on the transaction, our client was not liable to pay the said amounts. The Courts agreed with our submissions and proceeded to issue orders in favour of our client. We are also currently handling similar cases with our clients in the IT industry who have Withholding Tax exposures.
- ✓ Successfully represented a manufacturing company in a dispute relating to the demand of import VAT by the customs department and yet the materials the subject of alleged import VAT had been imported under the inward processing procedure (IPP) hence exempt from import duties.
- Successfully represented a group of companies in a reconciliation dispute leading to overestimation of the company's revenues which affected the payable VAT and corporate taxes.

✓ Successfully represented a client in a demand of alleged taxes and yet the client had made overpayment in previous years and hence had withholding credits under the legacy system that could be utilized by the KRA to offset any tax owing from it under Itax system.

#### 2. KRA Audit assistance


